**VOLUNTARY PARTICIPATION AGREEMENT
FOR ALL INTERVIEWS AND AUDITIONS**

I, _____ desire to voluntarily participate in interviews and/or auditions (the "Activity") in connection with that certain proposed television program tentatively entitled "GROOMER HAS IT" (the "Program"). In connection with my participation in the Activity, I acknowledge, represent, warrant and agree as follows:

- (1) I am 18 years of age or older.
- (2) I am in good health and I have no medical, physical or emotional condition that might interfere with my participation in the Activity.
- (3) I am not under the influence of any medication, drugs, or other substance that might impair my physical or mental ability to participate in the Activity or that might impair my judgment while participating in the Activity.
- (4) I will follow all rules made and directions given by Bongo, INC., (collectively, "Producer") in connection with the Activity.
- (5) I will abide by all applicable U.S. and state laws during the application process and, if selected, during the Activity.
- (6) I agree to receive all medical exams and immunizations that Producer deems necessary and/or medically appropriate. I'm willing to participate in the Activity without any interruption during any time of the year, regardless of personal or religious practices.
- (7) If selected, I agree to authorize Producer to conduct a thorough investigation into my background and personal history (including, without limitation, my medical and psychological history).
- (8) I am not a candidate for public office and I agree not to become one until 12 months after initial broadcast of all episodes of the Activity in which I appear, if selected as a participant.
- (9) I agree to pay all federal, state and local taxes, including income, use or sales taxes or any other governmental charges imposed on prizes, including the value of any goods or services received and cash gifts, if any, given to me or received by me by reason of participation in the Activity, and I release and indemnify Producer, from any liability therefore. I also authorize Producer to deduct or withhold any such taxes or charges that require a payment prior to delivery of said prizes, cash or gifts.
- (10) If I'm selected to participate, before I can participate in any manner whatsoever with respect to the Activity, I shall be required to re-execute this document (as amended, if required by Producer at its sole discretion), and to sign a Release and a Confidentiality Agreement and any other documents that Producer deems necessary to participate in the Activity.
- (11) Producer has no obligation to me whatsoever. Without in any way limiting the foregoing, I acknowledge and agree that Producer is under no obligation to select me to participate in the Activity and/or the Program and/or to include the Activity and/or my participation in the Activity in the Program. I understand that I will not be paid any money or given any other consideration for giving Producer the rights listed in this Agreement or for signing this Agreement and that such rights are freely given to Producer in exchange for Producer's interviewing and/or auditioning me.
- (12) MY PARTICIPATION IN THE ACTIVITY IS AT MY OWN RISK. I HEREBY RELEASE PRODUCER AND EACH OF PRODUCER'S RESPECTIVE OFFICERS, DIRECTORS, AGENTS, ATTORNEYS, REPRESENTATIVES AND EMPLOYEES, AFFILIATES, PARENTS, SUBSIDIARIES, LICENSEES AND ASSIGNEES AND ALL OTHERS CONNECTED WITH THE PROGRAM, FROM AND AGAINST ANY AND ALL CLAIMS, ACTIONS, DAMAGES, LIABILITIES, LOSSES, COSTS AND EXPENSES, IN ANY WAY ARISING OUT OF OR RESULTING FROM MY PARTICIPATION IN THE ACTIVITY, INCLUDING, WITHOUT LIMITATION, ANY AND ALL CLAIMS, ACTIONS, AND LIABILITIES FOR INJURY, LOSS OR DAMAGE TO ME, TO ANYONE ELSE OR TO ANY

PROPERTY, REGARDLESS OF WHETHER OR NOT SUCH INJURY, LOSS OR DAMAGE WAS CAUSED BY THE NEGLIGENCE OR WILLFUL MISCONDUCT OF PRODUCER OR ANY OF THEIR RESPECTIVE OFFICERS, DIRECTORS, AGENTS, REPRESENTATIVES OR EMPLOYEES, OR ANYONE ELSE CONNECTED WITH THE PROGRAM. I AGREE TO DEFEND AND INDEMNIFY PRODUCER AND EACH OF THEIR RESPECTIVE OFFICERS, DIRECTORS, AGENTS, REPRESENTATIVES AND EMPLOYEES, AND ALL OTHERS CONNECTED WITH THE PROGRAM, AND HOLD EACH OF THEM HARMLESS FROM ANY AND ALL LIABILITIES, CLAIMS, ACTIONS, DAMAGES, EXPENSES AND LOSSES (INCLUDING, WITHOUT LIMITATION, ATTORNEYS' FEES) OF ANY KIND OR NATURE WHATSOEVER IN ANY WAY CAUSED BY OR ARISING OUT OF MY PARTICIPATION IN THE ACTIVITY.

(13) I am aware it is a Federal offense, unless disclosed to Producer prior to broadcast, for me to accept or agree to accept anything of value for promoting any product, service or venture on the air. I am also aware that it is a Federal offense to use any prepared material containing such a promotion where I know the writer received consideration for it and fail to disclose this to Producer prior to broadcast. I am also aware that Federal law prohibits "payola" and "plugola", and I acknowledge, among other things, that it is unlawful to accept anything of value for promoting any product, service or company or arranging for any person to appear in connection with the Program. I represent and warrant that I have not violated and will not violate any such law. I further represent and warrant that I have neither paid nor accepted and shall not pay or accept any money, service or other valuable consideration for the inclusion of any plug, reference or product identification or any other matter in the Program, and that I have no knowledge of any payment of any valuable consideration for the inclusion of such a matter in the Program. I understand that Producer's policy prohibits payments for arranging personal appearances and that failure to disclose to Producer any such arrangement constitutes a Federal crime. I agree that I will promptly deliver to Producer, upon request, such affidavits and statements as either of them may require in connection hereunder or under the Federal Communications Act and related laws or regulations.

(14) Any material I provide to Producer (including, without limitation, videotapes, photographs, etc.) and all material that Producer creates as part of the Activity shall remain the sole property of and shall be freely assignable by Producer. I further understand and agree that whether or not I am selected for any further consideration as a participant in the Program, Producer shall nevertheless have the right to use my name, voice, likeness, appearance, biographical information, any information or material provided by me to Producer, and any motion or still pictures or recordings Producer may make of me, in any and all media now known or hereafter devised, worldwide in perpetuity, and I hereby release Producer from any and claims, actions, damages, liabilities, losses, costs and/or expenses arising out of or resulting from Producer's exercise of its rights hereunder. I understand and acknowledge that no cause of action arising from this Agreement shall grant me the right to restrain or otherwise enjoin the development, production, distribution, exhibition or other exploitation of the Program or the advertising thereof. My sole remedy, if any, shall be an action at law for damages.
